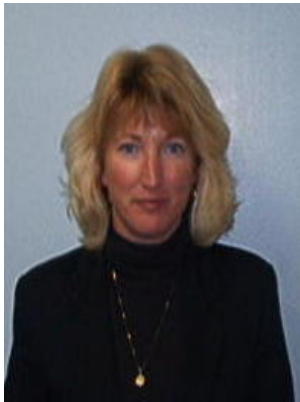


MEET YOUR 2010 OFFICERS
